Q .1 What is the Basic System Requirement for bcasonline.org or which browser supports the website?

Ans : Minimum system requirement with minimum 2mbps internet speed as follows :

- Pentium 233-megahertz (MHz) processor or faster (300 MHz is recommended)
- At least 64 megabytes (MB) of RAM (128 MB is recommended)
- At least 1.5 gigabytes (GB) of available space on the hard disk
- CD-ROM or DVD-ROM drive
- Keyboard and a Microsoft Mouse or some other compatible pointing device
- Video adapter and monitor with Super VGA (800 x 600) or higher resolution
- Internet Explorer 6.0 and above, Mozilla Firefox 2.0
