The philosophy under the GST law is to substitute exemptions with upfront payment of taxes and corresponding refunds, which should be automated and quick. However, with the systems still not geared up for automatic refund processing, exporters started facing working capital issues. Considering the difficulties faced by exporters, certain measures have been taken to ease the pressure on the exporters. Has it really eased the pressure or have these changes resulted in more challenges? The speakers in this workshop will analyze the changes in this regard.
