& clause by clause analysis**

The Central Goods and Services Tax, Act 2017 obligates all registered persons (other than Composition dealers and Input Service Distributors to file their annual returns and the last date for filing GST Annual return for the period July 2017 to March 2018 is 30th June 2019. While the Government has done its bit by releasing the online and offline utility for preparing filing Form GSTR-9, tax practitioners and the clients, small and medium enterprises are expected to wade through a huge mountain of information. Some of the information is available in ready to use form, but there are several other bits of information which will be compiled for the first time.

In view of the above, the Indirect Tax Committee of the BCAS has organised an interactive session, with a live demo, on the process of preparation and filing of the Form GSTR 9. The panellist will demonstrate the process of filing returns using live data on the GSTN website and also discuss various issues, validations, and the steps for error resolution.
