Workshop on Preparation of Consolidated Financial Statements under Ind AS

Dear Member,

Indian companies have adopted Ind AS since FY 2016-17. For companies who had multiple branches, subsidiaries, associates, joint ventures, etc. (including overseas), the process has been very complex especially for preparation of consolidated financial statements.

To understand the entire process of preparing consolidated financial statements for such large entities, we, at BCAS have organised a workshop at Reliance Industries Limited (RIL) where the senior team of RIL will share their experiences and processes involved in collating the information and preparing consolidated financial statements on quarterly basis. This workshop will be a unique experience to those who want to gain an understanding of the process.

The workshop will be for half day to be conducted at the premises of RIL, Ghansoli and will be led by Mr. Raj Mullick, Vice President, Finance and Accounts, Reliance Industries Limited.
