Preparation and Audit of financial statements for non Ind AS companies also pose several challenges every year. For such companies also, there are several developments affecting preparation and presentation of financial statements like, new and revised accounting standards notified by MCA, accounting for GST, amendment in Companies Act, 2013 and so on. Further auditors also need to keep in mind the FRRB and QRB observations to improve the quality of reporting.

To keep the members as well as other stakeholders aware and abreast of the compliances and reporting requirements for finalising audits for the F.Y.2017-18, BCAS has planned this 1-day workshop. It will provide insights into the intricacies to be dealt with in reporting as per the new and revised requirements.
