## Workshop on Provisions & Issues - Export/ Import / Deemed Export/ SEZ Supplies

Dear Member,

The philosophy under the GST law is to substitute exemptions with upfront payment of taxes and corresponding refunds, which should be automated and quick. However, with the systems still not geared up for automatic refund processing, exporters started facing working capital issues. Considering the difficulties faced by exporters, certain measures have been taken to ease the pressure on the exporters. Has it really eased the pressure or have these changes resulted in more challenges? The speakers in this workshop will analyse the changes in this regard. The workshop will also include a panel discussion where both the speakers will present their views on common issues faced by the participants.
