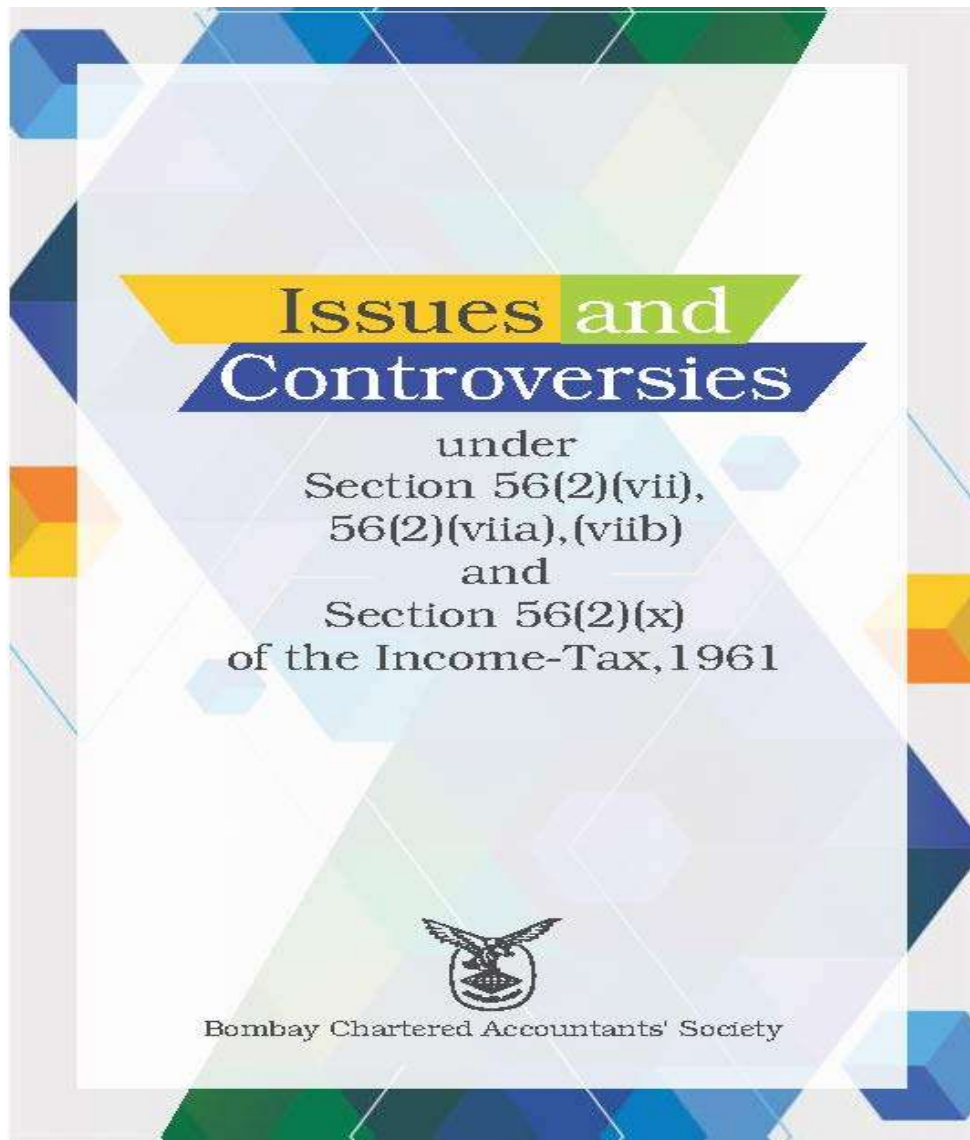

Title	Issues and Controversies under Section 56 (2) (vii), 56 (2) (viii), (viib) and Section 56(2) (x) of the IncomeTax,1961
Features	Section 56 of the Income-tax Act, 1961 has grown from strength-to-strength and its coverage has also been widened over the past few years. The provisions affecting companies have created a lot of discussion in professional circles. The infamous “Angel Tax” as known in popular terms has become a subject matter of heated debate amongst tax professionals, media and corporates. Apart from these specific provisions relating to companies, the general provision relating to taxation of gifts in excess of Rs. 50,000 from unrelated persons has also seen a lot of changes over the years.
