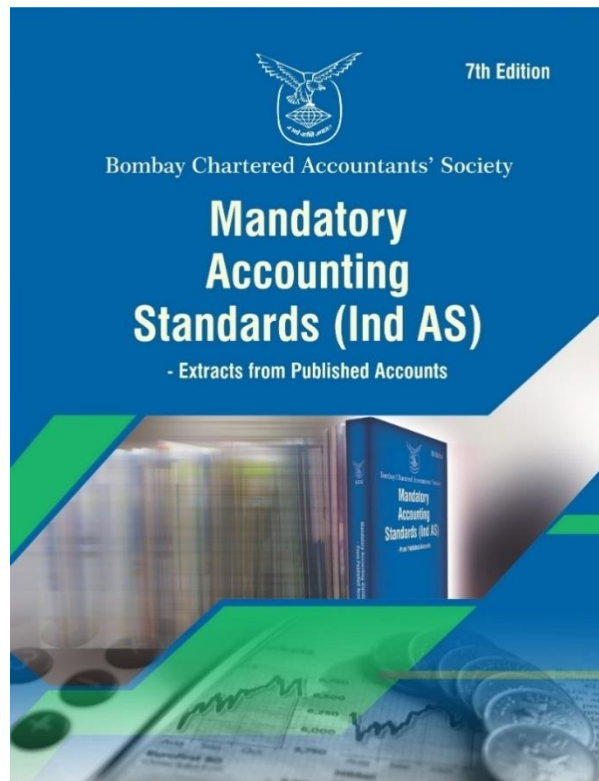

**Mandatory Accounting Standards (IndAS)-From Published Accounts (Book with CD)**

<b>Features</b>	<p>Compliance of Accounting Standards plays a very significant role in bringing about uniformity and transparency in the financial reporting by all the reporting entities.</p> <p>Indian Accounting Standards (IndAS) are being introduced in India in a phased manner. As per the phase-wise implementation, all listed and other companies having a net worth exceeding Rs. 500 crore (as on 31st March, 2014) adopted IndAS with a transition date of 1st April, 2015 and the first set of financial statements using IndAS were for the Financial Year 2016-17. From the Financial Year 2017-18, all remaining listed companies and those having a net worth of more than Rs.250 crore require to adopt IndAS. The companies in the second phase of IndAS would have the benefit of the implementation experience of the companies in the first phase.</p> <p>To continuously keep our members, professionals at large and all the stakeholders abreast with the latest developments in financial reporting, BCAS has been publishing the 7<sup>th</sup> Edition of the book “Mandatory Accounting Standards — Extracts from Published Accounts”.
